Eligibility Requirements:

- Must have two to eight years of experience regardless of age.
- Must be a member of the State Bar of Texas in good standing.
- Must be a member of the Tax Section of the State Bar of Texas (if not a member, must join prior to the commencement of the Leadership Academy).
- ➤ Must be willing to attend all four sessions.
- Note: Depending on the number of applications received, we reserve the option of limiting the Leadership Academy to one participant per firm office.

Tentative Meeting Dates and Cities:

- ➤ Dallas Session September 18-19, 2025
- ➤ Houston Session January 29-30, 2026
- Austin Session—March 26-27, 2026
- ➤ San Antonio Session (graduation) June 17-18, 2026
- Note: The sessions begin at approximately 5:00 p.m. on the first day and end by 5:00 p.m. on the second day, except for the San Antonio Session, which begins earlier on June 17, 2026 and ends with the Tax Section's Annual Meeting on June 18, 2026.

Cost and Payment:

- The admission fee for the SBOT Tax Section Leadership Academy is \$850.00.
- > Payment will be requested for each applicant upon notification of acceptance to the program.
- Scholarships are available upon request, on a limited basis, for qualified applicants to cover the admission fee.
